The District Educational Officer, Bhadradi kothagudem has caused inspection in this regard and submitted his report in the reference 2<sup>nd</sup> cited.

After careful examination of the proposals received from the Society and also as per the inspection report of the District Educational Officer, Bhadradi kothagudem through the 2<sup>nd</sup> cited and in terms of the orders issued in the reference 4<sup>th</sup> cited permission is hereby accorded for opening of Classes PP to X (E.M) at a time in respect of MONTESSORI PRIME SCHOOL, 14 Basthi, Yellandu, Mandal Yellandu, Bhadradi Kothagudem District from the academic year 2025-26 with instructions to follow the following instructions:

01. That the society shall be aide to the rules and regulations made in the Govt. orders 3<sup>rd</sup> cited above.
02. That the Society shall provide the necessary amenities like accommodation sanitary facilities, drinking water facilities, furniture, Library, Laboratory, equipment play field required staff as per the staff pattern another facilities before approaching the competent authority.
03. That the Society shall apply for recognition by immediately at the latest duly fulfilling the conditions.
04. That the permission is accorded is restricted to this year only and it is not valid for the subsequent academic year.
05. That this permission does not confer any right on the society for claiming recognition.
06. That the permission is accorded to the Montessori Educational Society and no other society of body can open a school on their behalf.
07. The permission is accorded to open to the school permission in the locality there shall not be a change in the premises of locality.
08. The society shall provide the necessary material even if it is costs more that the deposit amount.
09. Proper and adequate parking area for vehicles shall be provided transporting the children to and for the school.
10. Proper and adequate sanitation facility shall be provided for students especially for girl students.
11. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments

13. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children
14. The school shall have first aid kit and the teachers shall be trained in first aid.
15. The above permission is accorded purely on a temporary basis and is subjected to the reports of State Level Inspection and Vigilance Committee fulfilling of all the perquisite condition under the T.G Education Act 1982 and if later found that the school has not fulfilled any perquisites as stipulated, the permission now being given is liable to be withdrawn at once.
16. The permission is accorded for classes PP to X (E.M) with single sections only (Each class) and further the management shall have no right to put any branches with this permission order.
17. The Management has to follow the government norms from time to time, for collection of fee from students.
18. If the Management provides transportation, it is the responsibility of the Management to submit Fitness Certificates of their buses every year regularly to the D.E.O. to have skilled, Trained, Licensed and healthy driver. If any deviation in this matter, they will be personally held responsible.
19. The Correspondent to submit Provisional Recognition proposals within 90 days failing which opening permission is deemed to be cancelled.
20. The school name should be displayed in the Website of CSE.


